Terms and Conditions

The Heritage Point Water Works will bill the Lot Owner for water service every 6 months. Bills for service are due on the first day of July and January each year. Late fees apply to payments received after 30 days. Water charges are subject to change by the Heritage Point Water Board.

IT IS YOUR RESONSIBILITY TO NOTIFY THE HERITAGE POINT WATER WORKS BEFORE DOING ANY WORK ON THE WATER LINES ON YOUR LOT. THIS INCLUDES ANY: MAINTAINANCE, REPAIR, CHANGE, UPGRADE, ADDITION AND/OR THE INITIAL CONNECTION. THIS REQUIREMENT IS A HEALTH ISSUE.

The Lot Owner is solely responsible for all water charges. Failure to receive a bill will not be considered as an excuse for non payment. The Lot Owner fully understands that with notice, the Heritage Point Water Works will terminate service when an account remains unpaid for more than 60 days. When water service is terminated for non payment, shut-off and turn-on fees are applied. All monies owed to the Heritage Point Association and Divisions must be paid before water service will be resumed. Unauthorized operation of the curb valve is a violation of Virginia law. The Heritage Point Water Works will maintain and replace all water service connections from our water main to your Lot. You are responsible to pay for and maintain the water connection from your Lot line to your house.
